Dehradun will have the overall administrative control of the Institute and will provide high level leadership to the Institute in identification of research programmes and projects of national and international relevance in various specialized fields of research undertaken by the Institute. He/She will enthuse and motivate scientists of the Institute; promote creativity and excellence and create an atmosphere conducive to harmonious functioning of the Institute. He/She will interact and establish rapport with national and international, academic and professional institutions and specialists dealing with the domain area of research undertaken by the Institute and will ensure multi-disciplinary and multi-institutional co-operation towards fulfillment of the objectives of the Institute.
