- (ii) The qualifications and experience mentioned are the minimum requirement. The Institute reserves the right to short list the candidates based on their merit record, qualifications, experience and suitability of Institute's need.
- (iii) In the event of number of applications being large, WIHG will adopt shortlisting criteria to restrict the number of candidates to be called for Recruitment Test and or Interview to a reasonable number by any or more of the following methods:
  - (a) On the basis of Desirable Qualification (DQ) or any one or all of the DQs if more than one DQ is prescribed.
  - (b) On the basis of higher education qualification than the minimum prescribed in the advertisement.

- (c) On the basis of higher experience in the relevant field than the minimum prescribed in the advertisement.
- (d) By counting experience before or after the acquisition of essential qualifications.
- (e) By invoking experience even in cases where there is no experience mentioned either as Essential Qualification (EQ) or as Desirable Qualification (DQ).
- (f) By holding a Recruitment Test.

**THE CANDIDATE SHOULD, THEREFORE, MENTION ALL HIS/HER QUALIFICATIONS AND EXPERIENCE IN THE RELEVANT FIELD OVER AND ABOVE THE MINIMUM QUALIFICATIONS.**

- (iv) Age relaxation is applicable to SC/ST/OBC category as per Govt. of India Rules. The upper age limit is relaxable for Central/U.T. Govt. servants upto 5 years as per instruction issued by the Govt. of India from time to time. (This implies that Scheduled Caste/Schedule Tribes category candidates would get maximum 10 years age relaxation including 5 years age relaxation meant for their respective categories. Similarly OBC candidates would get maximum upto 8 years including 3 years age relaxation meant for OBC category). This relaxation will be admissible to Government servants with 3 years continuous service in Central Government and working in posts which are in the same line or allied cadre and where a relation could be established that the service already rendered in that particular post will be useful for the efficient discharge of the duties of the post to which recruitment is being made. Decision in this regard will rest with the WIHG. A candidate claiming to belong to the category of Central Government servant and thus seeking age relaxation under this para would be required to produce a certificate. Age relaxation is also applicable to person with disabilities, Ex-servicemen, widows, divorced women and women judicially separated from their husbands and who are not remarried is available as per Govt. of India Rules.
- (v) That the engagement is for a temporary nature of work and is purely on contractual basis for a fixed period of one year, which can be extended depending upon the requirement of the Institute. However, further continuation will depend on satisfactory performance and review of work. Thereafter the same can be extended for one or more year by the Institute in writing from time to time, depending upon the exigencies and requirements of work at Institute's sole discretion.. This contractual engagement is purely occasional and does not entitle him to any regular employment in the services of the Institute.
- (vi) HRA means House Rent Allowances as applicable at Dehradun.
- (vii) In case the performance of the selected candidate is not found satisfactory, the appointment shall be terminated at any stage of the tenure.
