- The tender forms be clearly filled in ink legibly or type written giving full address of the bidder. The bidder should quote in figures as well as in words the rates/amount tendered by himself. Alteration/overwriting unless legible attested by the Bidder, shall disqualify the Bidder. The tender should be signed by the Bidder himself or his authorized agent on his/their behalf (Authorization may be enclosed, if applicable).
- The forwarding letter undertaking (Annexure-I) duly signed by the tenderer should invariably be returned along with quotation furnished failing which the tender shall be rejected.
- The EMD amounting to **Rs.8000.00** in the form of DD/FDR to be submitted before the last date of submission of tender at Store & Purchase Section, Wadia Institute of Himalayan Geology, Dehradun-248001 failing which the tender shall be rejected.
- The Bidder should take care that the rates and amount are written in such a way that interpolation is not possible. No blanks should be left which would otherwise make the tender rejected.
- Each tender should be accompanied with an EMD/bid security amounting to Rs.8,000/- in the form of FDR/DD drawn in favour of "**Director, Wadia Institute Of Himalayan Geology**" and the same should be from any Nationalized bank, failing which the tender shall not be considered for acceptance and will be outrightly rejected. The EMD/Bid security deposited against other tender cannot be adjusted or considered for this tender. No interest is payable on

EMD/Bid security. The EMD of successful firm/bidder will only be returned after auction and the offer is awarded and the balance amount is deposited in the Institute. However, the EMD of other unsuccessful bidder will immediately be returned just after awarding the offer.

6. Space should be left clear after lifting their belongings by the approved vender failing which EMD/BID security will be forfeited.
7. Successful Bidder shall have to lift the Vehicles within Seven (7) working days of the issue of offer letter subject to submission of full payment by the bidder, during working days (i.e. up to 4:00 p.m. on all working days) failing which a ground rent @ Rs. 500/- per day will be charged till the final lifting of the goods by bidder. No shifting will be permitted on Saturday and Sundays and Govt. Holiday, selected parties (highest bidder) shall be allowed to lift or load condemned Vehicle only after issue of gate pass by the Store Section of WIHG, Dehradun.
8. **Firm shall include a copy of Firm's registration, Pan Card, GST No. Tender acceptance letter (certified copy) Aadhar/Address Proof, Bank A/cs details etc.**
9. The Director, WIHG, Dehradun, reserves the right to cancel/ reject full or any part of the tender which does not fulfill the terms and conditions stipulated in the limited tender.
10. In the event of any disagreement, dispute, difference between the Institute and the Bidder/Vendor, the Hon'ble High Court of Nainital, Uttarakhand shall be the sole adjudicator of the dispute.
11. Bidders submitting, tenders would be considered to have accepted all the terms & conditions. No inquiry verbal or written shall be entertained in r/o acceptance or rejections of the tender.
12. Any action on the part of the Bidders to influence anybody in the Institute will be taken as an offence. He will not be allowed to participate in the tender inquiry and his tender will be rejected.
13. Any damage to the property of the WIHG if noticed, due to the fault of the successful bidder during lifting the items shall be recovered from the said firm and the decision of the Director, WIHG, Dehradun shall be binding on the bidder.
14. Decision of the Director, WIHG, Dehradun will be final on all issue/Objection, and no inquiry will be entertained after tender opening.
15. Inspection of the vehicles lying in WIHG, Dehradun, Store & Purchase Section will be done only by the prospective bidders during office hours 09:30 A.M. to 05:30 P.M. before submitting the quotation.
16. **THE BIDDERS ARE ADVISED TO QUOTE THEIR RATE INCLUSIVE OF ALL TAXES & EXPENSES, AS APPLICABLE IN THE ANNEXURE-II (enclosed). ALL THE LIABILITIES REGARDING TAXES/LEVIES WILL BE UPON THE SUCCESSFUL BIDDER ONLY.**
